This report, prepared pursuant to section 20(5) of the Social Services Law (SSL), concerns:

- A report made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) involving the death of a child.
- The death of a child for whom child protective services has an open case.
- The death of a child whose care and custody or custody and guardianship has been transferred to an authorized agency.
- The death of a child for whom the local department of social services has an open preventive service case.

The Office of Children and Family Services (OCFS) is mandated by section 20 of the SSL to investigate or cause for the investigation of the cause and circumstances surrounding the death, review such investigation, and prepare and issue a fatality report in regard to the categories of deaths noted above involving a child, except where a local or regional fatality review team issues a report, as authorized by law.

Such report must include: the cause of death; the identification of child protective or other services provided or actions taken regard to such child and child’s family; any extraordinary or pertinent information concerning the circumstances of the child’s death; whether the child or the child’s family received assistance, care or services from the social services district prior to the child’s death; any action or further investigation undertaken by OCFS or the social services district since the child’s death; and as appropriate, recommendations for local or state administrative or policy changes.

This report contains no information that would identify the deceased child, his or her siblings, the parent, parents, or other persons legally responsible for the child, and any members of the deceased child’s household.

By statute, this report will be forwarded to the social services district, chief county executive officer, chairperson of the local legislative body of the county where the child died and the social services district that had legal custody of the child, if different. Notice of the issuance of this report will be sent to the Speaker of the Assembly and the Temporary President of the Senate of the State of New York.

This report may **only** be disclosed to the public by OCFS pursuant to section 20(5) of the SSL. **It may be released by OCFS only after OCFS has determined that such disclosure is not contrary to the best interests of the deceased child’s siblings or other children in the household.**

OCFS’ review included an examination of actions taken by individual caseworkers and supervisors within the social services district and agencies under contract with the social services district. The observations and recommendations contained in this report reflect OCFS’ assessment and the performance of these agencies.

Presenting Information

The SCR report alleged on 12/27/21, at 7:30PM, the mother gave the one-year-old male subject child (SC) Tylenol for teething and a fever. Eventually, the SC fell asleep in his crib with a blanket. On 12/28/21, at 1:30AM, the parents checked the SC and he was breathing. At 7:40AM, the parents checked the SC and found him unresponsive. The father removed the SC from the crib and initiated CPR while the mother called 911. EMS arrived at 7:59AM and transported him to the hospital. The SC was pronounced deceased at 8:41AM on 12/28/21. The SC was otherwise healthy and the parents had no explanation for his death.

Executive Summary

This fatality report concerns the death of a one-year-old male subject child (SC) who died on 12/28/21. The allegations of the report were DOA/Fatality and IG of the SC by the parents. The parents declined an autopsy due to religious reasons. An examination was completed by the Medical Examiner who ruled the cause and manner of death as Undetermined.

The parents had no other children.

ACS learned that on the day before the incident, the SC had a fever that the parents suspected was due to teething. The mother administered medicine at approximately 7:50PM. The father checked the SC at approximately 1:30AM and 3:30AM on 12/28/21 and he was asleep and breathing. At approximately 7:40AM, the parents checked the SC and found him unresponsive. The father administered CPR as the mother summoned 911 for medical assistance. EMS transported the SC to the hospital where further attempts to resuscitate were unsuccessful. He was pronounced dead at 8:41AM on 12/28/21. The hospital staff found no signs of maltreatment or abuse on the SC. LE found no criminality.

The parents reported the SC was not sick prior to 12/27/21. They reported no mental health conditions or DV in the home. ACS documented the home was clean and had appropriate resources to meet the SC's needs.

On 2/7/22, ACS received medical information that reflected the SC was last seen by the pediatrician on 12/3/21. There were no medical concerns and the SC was up to date with his immunizations. The collaterals had no concerns with the parents and the care they provided to the SC.

On 2/26/22, ACS unsubstantiated the allegations of DOA/Fatality and IG of the SC by the parents citing no credible evidence was found to support the allegations. The parents declined all offers for services.

LDSS Response

Upon receipt of the SCR report, ACS initiated an investigation by contacting hospital staff, ME and LE. The hospital staff reported the SC was found with no marks or bruises that indicated maltreatment or abuse, and signs of rigor mortis inhibited efforts of resuscitation.

LE reported that upon their arrival to the home, they observed the SC in the ambulance. The ME reported the SC's postmortem COVID-19 test result was positive. The ME reported signs that the SC had a fever prior to his death.

On 12/28/21, ACS visited the case address, interviewed the parents, and documented no safety hazards. The parents reported the SC was healthy prior to 12/27/21 when he began to feel feverish. The mother stated that she knew the SC was teething because his cheeks were pink in color. She administered medicine but could not recall the dosage. The parents said the SC fell asleep and was placed in his crib on his stomach with his head facing the left side. The father stated the only item in the crib was a teddy bear, placed on the other side of crib away from the SC. Information regarding safe sleeping positions for infants was provided.

The parents reported the SC was usually awake at 7:00AM; however, he was quiet on the morning of his death. They said they checked him at 7:40AM and found him unresponsive and not breathing.

ACS confirmed the parents traveled outside of US on 12/28/21 to bury the SC in another country. The family declined services and were out of the country for most of the investigation.

On 2/26/22, ACS unsubstantiated the allegations of DOA/ Fatality of the SC by the parents citing no credible evidence was found to support the allegation. ACS found that the parents provided adequately for the SC.
